Policies

1. I permit my child to attend YWCA-sponsored field trips on weeks that my child is registered for camp. Additional information on trips will be furnished to parents prior to the date of the field trip.
2. I permit the YWCA or an acting agent to photograph my child for program purposes. I understand that these photos may be used by the YWCA in any manner; including advertising or publicity, and that I will not be compensated for their use.
3. I agree to identify any behavioral concerns or special physical, emotional, psychological or medication needs of my child with the Youth Services Coordinator prior to submitting this registration form.
4. In the event of an emergency in which I cannot be contacted, emergency medical personnel and the YWCA may take appropriate actions in the best interest of my child.
5. I understand that I must furnish to the YWCA my child's current immunization record with a doctor's signature if my child is not enrolled in Wake County Public Schools.
6. I understand that campers' families are responsible for their own accident insurance during YWCA activities.
7. I understand that the YWCA has a Summer Program Parent Handbook, which will be provided to me upon registration of my child in the program.
8. I understand that the YWCA is not responsible for any personal items lost or stolen during YWCA program activities.
9. I understand that the YWCA can only administer physician-prescribed medications. If my child requires medication, I will deliver it to the YWCA in the original container, with original pharmacy or physician instructions.
10. I understand that campers must arrive by 9:00 a.m. and depart no later than 6:00 p.m.
11. If I choose the bank draft payment method, I understand that fees for camp weeks beginning in June will be drafted from my account on June 1, 2010; payments for camp weeks beginning in July will be drafted July 1, 2010; and payments for camp weeks beginning in August will be drafted August 2, 2010. A voided check is enclosed.
